Dear Sir,

This is with reference to the clarification sought by NSE by its mail dated May 29, 2018 for Quick Financial Results submitted to the Exchange on May 24, 2018 for the period ended on March 31, 2018 along with the following remark:

“1. Financial results submitted is not as per format prescribed by SEBI - Note on balancing figure not mentioned as per Reg.33.”

In this matter we wish to clarify that the Company was listed on the Exchange on December 8, 2017 and this is the first time when the half-yearly Financial Results of the Company are being published under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Therefore the note as per Regulation 33(3)(e) that ‘the figures of the half year ended March 31, 2018 and March 31, 2017 are the balancing figures between audited figures in respect of the full financial year and the ‘published’ year-to-date figures upto the 1<sup>st</sup> half years of the respective financial years’ was not made part of the notes to the Audited Financial Results.
